USDA management changes coming. After a January 6 hearing, the Senate Agriculture Committee unanimously recommended that Nebraska Governor Mike Johanns be confirmed as Secretary of Agriculture. The National Rural Housing Coalition reports that the Administration may renominate Tom Dorr to be USDA Under Secretary for Rural Development. He was a recess appointment to that job during President Bush's first term, and later was a special assistant to USDA Secretary Ann Veneman. RHS raises bonding threshold. Currently a builder with a contract for more than \$100,000 must obtain a payment and performance bond. The new threshold will be the local maximum single-family lending limit; therefore, bonding will not be required for single-family contractors.
