As, as Dan noted it, it typically happens a little bit earlier, but there's a little bit of an unusual year. And then Congress takes up.

Uh, the appropriations process initially with budget resolutions that are drafted, voted on and then conferenced in the House and the Senate.

And based on those budget, that budget resolution, known as the 302 a each of the uh appropriation subcommittees get what's known as there's 302 B.

Uh and then conference in the House and the Senate. Let me just make a quick note that this is the the Civics 101 version of how the appropriations process works. However, absent the situation where you have unified control and 60 votes in the Senate, there's often disagreement about the top line of amount. The so called 302 A.

So you often have a circumstance in which the Senate and the House Appropriations committees and their sub committees are working toward different numbers, and that has to be resolved later in the process. I'm on my 26th federal budget and I can count on one hand the number of times it's followed, exactly like this slide. So what happens if the process fails? Well, you get continuing resolutions, level funding until an appropriations.

Act is signed into law or in the case of each of the instances in which power has changed hands. At the first midterm elections after a new administration, 1994 and 2010 government shutdowns.

I should make one more point because it is relevant to this budget proposal, which is what I've just described, describes the discretionary spending process. There is also, in fact, the majority of federal

spending is so called mandatory spending. Mandatory spending programs are created by authorizing or policy committees, rather than the appropriations committees. Medicaid and Medicare are well known examples of mandatory spread.

Spending programs, so was the proposed build back better act so thus as their discretionary appropriations proposals move through the process I've just described, there is likely also to be a negotiation with authorizing committees on the major mandatory spending proposals that are contained in this budget, which we'll get to shortly.

Rental assistance is available only if the property has a USDA section 515 or 514 loan, and if the USDA mortgage ends, the property loses its eligibility for RA.
