We are pleased to present the 2021 Rural Development Multi-Family Housing (MFH) Annual Fair Housing Occupancy Report, which includes both Section 515 Rural Rental Housing (RRH) and Section 514 Farm Labor Housing (FLH) properties. These results are based on October 2021 data from the Multi-Family Integrated System (MFIS) database.

This report presents data from the past three years, comparing information from years 2019 to 2021. Attachment A is a summary of report results. Highlights of this year's data include:

- The total number of rental properties has decreased by 1.00 percent since last year, or a decrease of 108 Section 515 properties and a decrease of 25 FLH properties. The number of rental units in the MFH portfolio has decreased 0.41 percent. Overall we saw a reduction of 133 properties in the past year, representing 1,709 apartment units.
- The current population shows a slight decline in overall population. The breakdown now consists of:

White, Non-Hispanic households:	64.69 percent
Black, Non-Hispanic households:	20.30 percent
Hispanic households:	11.91 percent
Asian, Pacific Islander households:	0.70 percent
American Indian/Alaskan Native households:	1.64 percent
Multi-Racial households:	0.76 percent
- There was a slight decrease in very-low income households, which represent 91.66 percent of all households. Low income households represent 7.20 percent of the total.
- Average household incomes are up to \$14,665 from \$14,131, a 3.78 percent increase. The average income of Rental Assistance (RA) households increased to \$12,501 from \$11,669, a 7.13 percent increase.

- Female-headed households continue to represent the majority of households (70.70 percent).
- There was no appreciable change in the percentage of elderly/disabled households versus non-elderly households.
- The disabled population also has no appreciable change within the elderly/disabled households.

In comparing the Section 515 portfolio with the Section 514 portfolio, it is interesting to note:

- FLH members per household are about twice the size of the average household in the portfolio. Average farm labor income is almost twice as much as the average RRH portfolio household (\$27,797 vs. \$14,148). Farm labor income for RA households, \$19,871, is significantly higher than the average RA income for the RRH portfolio, \$12,235.
- Elderly/disabled households make up 65.61 percent of the RRH portfolio but only 24.71 percent of the FLH households.
- RA households make up 76.3 percent of the RRH portfolio and 69.9 percent of the RLH households. RRH and FLH both showed an increase in RA households compared to last year.
- White households constitute 67.0 percent of the RRH portfolio, while minorities constitute 93.9 percent of FLH households.

The report also shows a 6.27 percent increase in the number of households using RA compared to last year. Rent overburdened households (those paying more than 30 percent of their adjusted income toward rent) showed a large decline (92.15 percent) due to Emergency RA funds that were distributed during the Fiscal Year.
