

# HUD's Rural Capacity Building for Community Development Program

Technical Assistance provided to rural organizations to increase affordable housing activities that benefit low- and moderate-income families and persons in rural areas.







## Substance Use Disorders, Opioid and Alcohol Misuse

#### 2021 National Survey on Drug Use and Health (NSDUH)

- 46.3 Million People Diagnosed with Substance Use Disorders
- 6,742,000 people in rural areas were diagnosed with Substance Use Disorders
- 94% of people 12 years or older diagnosed with Substance Use Disorders did not receive treatment.

#### **CDC Provisional Drug Overdose Death Counts**

- May 2020 to May 2021 was the first 12-month period with over 100,000 overdose deaths in US history.
- August 2021 August 2022 had 101,554 overdose deaths

## **Guide Format**

#### **Federal Regulations**

#### **Applicable Terms and Definitions**

The federal regulations include the use of terms with specific federal definitions. The following definitions from the federal regulations are applicable to housing residents with substance use disorders.

**Applicant** (24 CFR § 982.4): A person or a family that has applied for admission to housing.

**Covered Person** (24 CFR § 5.100): For the purposes of screening and terminating tenancy for criminal activity, a tenant, any member of the tenant's household, a guest, or another person under the tenant's control.

**Housing Choice Voucher Program** 

#### **Public Housing Authorities**

- Create an administrative plan
- Applicant selection and denial policies
- Screening for "suitability of tenancy"
- Applicants previously evicted for illegal drug use on federally subsidized housing are placed on a threeyear ban
  - Applicants who demonstrate successful completion of a monitored recovery program may be considered
- Applicants convicted for manufacturing methamphetamine on the ground of federally subsidized housing are banned

#### **Owners (landlords)**

- Screening for "suitability of tenancy"
- "Health, safety, or right to peaceful enjoyment of the premises.

### **Public Housing Program**

#### **Public Housing Authorities**

- Establish standards of admission
- Applicants convicted for manufacturing methamphetamine on the ground of federally subsidized housing are banned
- Holistic consideration of applications
  - Prior landlord interviews
  - Successful completion of an approved rehabilitation program
  - Rent payment history
  - Criminal record etc.

**Recovery Housing Program** 

Participating jurisdictions, once demonstrating an unmet need in the community in the Consolidated Plan, may develop specialized programs. Programs and housing may provide preference for households with disabilities if outlined in the jurisdiction's Consolidated Plan.

The program provides temporary housing and services for individuals recovering from substance use disorders for up to two years. Applicants must be in recovery from substance use disorder to meet the eligibility requirements for this program.

**Supportive Housing Program** 

Tenants must meet the criteria for experiencing homelessness. The program allows for housing and services for persons with disabilities, including impairments caused by alcohol or drug use.

**Shelter Plus Care Program** 

The program provides rental assistance and supportive services, primarily focused on persons experiencing homelessness with mental illnesses, chronic issues with alcohol and/or drugs, and HIV or AIDs. Applicants must meet HUD's definition of experiencing homelessness and disability for eligibility.

Section 811 Supportive Housing for Persons with Disability Program Applicants whose sole impairments are alcoholism or drug addiction are not eligible for this program. If the applicant has an addiction and another disabling condition, they may be considered for the housing and services.

Low-Income Housing Tax Credit Program The Qualified Action Plan (QAP) created by LIHTC allocating agencies must adhere to the general requirements.

- The QAP is permitted to include selection criteria for projects focused on populations with special housing needs.
- LIHTC regulations allow provisions of required supportive services, which are "designed to enable residents of a residential property to remain independent and avoid placement in a hospital, nursing home, or intermediate care facility for the mentally or physically handicapped."
- If additional federal affordable housing programs subsidize a LIHTC project, the regulations from the additional federal program must be adhered to in addition to the LIHTC regulations.

Single Family Loan Program: Section 502 Direct and Guarantee

Single Family Loan Program: Section 504

- The regulations do not include specific exclusions for applicants with SUD or a history of drug use.
- Financial requirements may be a barrier for some residents in recovery.
  - Applicants with significant financial delinquency within 36 months may be ineligible

### Section 515 Mortgage Program

- Persons with disabilities are eligible for services in congregate housing and group homes.
- The definition of disability includes individuals with physical or mental impairments due to drug addiction.
- Applicants with addiction caused by current and illegal use of a controlled substance are not eligible for services.

#### **Summary of Findings:**

- Residents in recovery may be eligible for federally subsidized housing
- Other requirements for the federal housing programs may result in being ineligibility
- The regulations do not account for funding and housing capacities in each locality
- Given high demand for affordable housing, eligibility does not guarantee acceptance to federally subsidized housing
