BUDGET AND APPROPRIATIONS PROCESS



- Step one: President proposes budget
- Step two: Budget resolution(s) are drafted, voted on, and conferenced in House and Senate
 - Based on budget resolution outcome, "302b" allocations are assigned to Appropriations Subcommittees
- Step three: Appropriations bills are drafted, voted on, and conferenced in House and Senate
- Should the process fail: Continuing resolution(s) or government shutdown(s)
- Parallel process: Mandatory spending/ reconciliation



Spending Caps

- Unlike past budgets from this Administration, the FY25
 White House Budget is limited by the strict spending
 caps agreed to by Congress and the White House under
 the "Fiscal Responsibility Act of 2023."
 - o This agreement allows for a spending increase of only 1% in FY25 compared to FY24.
 - The budget was written before FY24 appropriations were finalized, so it appears to rely somewhat on both FY23 levels and some assumptions on where FY24 was likely to land.

Proposed mandatory spending would include:

- \$20 billion for a new Innovation Fund for Housing Expansion
- \$10 billion for a new First-Generation Down Payment Assistance program
- \$3 billion for eviction reduction efforts
- \$8 billion homelessness grants



Proposed mandatory spending (cont.):

- \$7.5 billion for new PBRA contracts for ELI households
- \$7.5 billion for public housing modernization
- \$9.2 billion for vouchers for all 20,000 youth aging out of foster care
- \$13.1 billion for vouchers for all 400,000 ELI veteran families
- \$3 billion for emergency rental assistance for older adults at risk of homelessness
